PURCHASER AGREES TO THE FOLLOWING:

The Kitten described above **can be used for breeding purpose to a registered breeder.**

The kitten will be registered with TICA on **active register.**

The female kittens will not be bred before the kitten is one year of age or younger if three consecutive seasons have occurred with veterinarian agreement, will also not be bred more than 6 times total.

The kitten shall **not be sold on to any other breeder on active register with breeding rights, leased or given to pet shops or research establishments. The kitten must be spayed/ neuter before being rehomed, otherwise a penalty of £8000 will be paid to the Seller by the above-named Purchaser(s).**

Where the cat/kitten is being sold for export, associated veterinary and transport costs will be additional charge to the agreed sale price and are to be paid by the Purchaser(s).

The buyer understands that no cats/kittens from the above cat/kitten can be sold on an active Register in the United Kingdom.

In the event of the cat/kitten being infertile after 2 years of age, the vendor shall replace the cat/kitten of equal standard & value (upon receiving the appropriate proof). No cash refunds are given.

In the event of a fertility /health issue arising after the cat has produce live kittens (that have been sold, gifted or kept within the cattery NO replacements of any kind will be given.

The Saler cannot guarantee a female sold on active registry against pyometra.

NO STUD Service to be offered to any other breeder. Writing agreement of the breeder can be asked for rare exceptions in the interest of the buyer program.

The kitten will be kept in appropriate condition for the breed, energy levels, welfare and health, will be fed with a suitable diet for the breed, age & condition, will receive regular yearly vaccination from a veterinary surgeon and veterinary flea, worming parasitic control, to maintain its health.

A book leaf of INTRODUCING YOUR NEW KITTEN TO ITS NEW HOME WILL BE PROVIDED BY MAJESTICMEOWS.

No cash refunds will be given for any reason, if for some reason you need to re-home the kitten, we may not have the room to take the kitten back, but we will try to help by passing on enquires for you and advertise the kitten for rehoming on our website, the new owner will need to go through our interview process also before we agree to you allowing them to have the cat/kitten, this is for their safety and welfare.

We highly recommend you keep insurance after the 4 for pet plan or 5 for agria weeks have passed, this can save you unexpected expenses and cover your cat/kitten should any illness/accident/death arise, this is your cover. Failure to continue this insurance will invalidate your contract with us, also any claim you wish to make against us.

Insurance will start immediately from the time of collection.

Payment and Deposit Agreement:

The purchaser agrees that ANY payment/deposit received by the seller from the purchaser is NOT REFUNDABLE (e.g. CANCELLANTION).

You the purchaser agree to be responsible for continuation, upgrade if appropriate, for pet insurance to cover(once the free 4 weeks cover has finished) to help pay for the cost of veterinary treatments following unforeseen medical problems and illnesses/ injury/ accidents or death from illnesses or injury as THE SELLER WILL NOT BE RESPONSIBLE FOR ANY REIMBURSEMENT, REFUND OR REPLACEMENT due to the nature and vulnerability of a young pet/ animals to risk and dangers leading to illness, injury and/ or death, due to the above reasons, as there are many risks the new owner must be aware of that entails in owning an animal pet after collection/ delivery, the breeder Adelina Ionita cannot be held liable or responsible for this kitten once it has left her care and facility.

You the purchaser agree to having researched the Bengal breed / Maine Coon breed, temperament and nature.

If for any reason (allergies, personal difficulties) you the purchaser feel the need to return the Bengal cat/kitten to **MajesticMeows**, you the purchaser can return the kitten at your own expense with no monetary refund, this is also subject to **MajesticMeows** having the necessary space to accommodate the kitten/cat you are wishing to return.

UNDER NO CIRCUMSTANCES CAN THE BENGAL KITTEN/CAT AND ITS PROGENIES BE DECLAWED/ TATTOOED!!!

HEALTH GUARANTEE:

Our cats/kittens come to you updated with vaccinations, and regular flea& worming treatment which is recorded inside the kitten's vaccination record, they are vet checked twice, they are guaranteed to be in good health at the time of sale, the guarantee is for 48 hours from leaving, and is valid providing the kitten has had no contact with any cats, this is reliant on him/her being vet checked **within 72 hours** of purchasing and we would need written proof from a veterinarian. If the kitten is to be found in unsound health by a veterinarian **within 72 hours of leaving the breeders premises the cat/kitten** shall be returned and the buyer may request a placement with another cat/kitten of equal equality. If it is a minor problem and you choose and you choose to have it attended by your own vet will be at your own expenses. For the protection of seller's residential cattery population, a portion of the purchase price will be retained for FELV/FIP and FIV for testing if the kitten is returned. Once the kitten leaves the possession of the breeder, the breeder cannot be held responsible for any veterinarian bills or charges incurred of the cat/ kitten. If you own other pets or have had any other pets within at last 24 months, I suggest you place your new arrival in a sanitised quarantined area for 14 days away from other animals/pets so that he/she may relax and get used to their new surrounding and from a strong bond with you the new owner/s. **Undesirable behaviour issues(spraying urination, scratching furniture, etc) developing once the kitten has been turned over to the purchaser are not conditions for a refund or return, but I am happy to help and advice you on any such behaviour, this kitten/cat is not leaving today with any such behaviour.**

Hypertrophic cardiomyopathy (HCM): A replacement guarantee is offered by the seller against positive testing for HCM, up to 24 months of age of the cat. If the cat's HCM test is equivocal, the seller may choose to extend this guarantee for a further 18 months or to call upon it in the same way as if the cat had tested positive for HCM.

In the event of the cat/kitten dying from a congenital defect within the first year of his/her life, the Seller shall replace the cat/kitten once with another kitten of equal standard and value (upon receipt of appropriate veterinary or laboratory results/proof).

No cash refunds are given.

The Seller cannot guarantee the cat/kitten success in show. The Vendor takes no responsibility for cosmetic changes to the cat/kitten's appearance that may occur as the cat/kitten matures.
